

RESOLUTION #14-172

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodbury, as follows:


1. That the excess in the appropriations listed in the column designed "FROM" be transferred to the appropriations listed in the column designated "TO" as follows:


2. The City Clerk is hereby authorized and directed to transmit to the Chief Financial Officer, of the City of Woodbury, a certified copy of this resolution.
