WHEREAS, the City Engineer has reviewed the bids and recommended an award to Gerald A. Barrett, LLC, the lowest responsible bidder in the amount of \$333,648.74; and

WHEREAS, the bid of Gerald A. Barrett, LLC is compliant in all material, non-waivable respects; and

WHEREAS, the Chief Financial Officer has certified the availability of funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Woodbury, that the Mayor and/or Administrator is hereby authorized to execute a contract with Gerald A. Barrett, LLC for the Wood Street Roadway Resurfacing and Storm Sewer Improvements Project consistent with the City's request for bids and the bid of Gerald A. Barrett, LLC in the amount of \$333,648.74.
