NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury that the sums set forth on the attached exhibit shall forthwith be charged as liens upon the property as set forth on the attached Exhibit "A" and shall be added to and become and form part of the taxes next to be assessed and levied upon such dwellings and lands and shall bear interest at the same rates as taxes and shall be collected and enforced by the same officers and in the same manner as taxes.
