- 3. The sale shall be held not less than seven (7) nor more than fourteen (14) days after the latest publication of the notice thereof;
- 4. The City of Woodbury reserves the right to reject all bids for any specific vehicle or all bids for all vehicles if it determines such rejection to be in the public interest; and

5. The sale will be conducted online and the address of the auction site is GovDeals.com; and

6. The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property and subject to the conditions as Exhibit A; and

City of Woodbury Municipal Building.
