RESOLUTION AUTHORIZING THE PURCHASE OF A WOOD CHIPPER THROUGH NATIONAL JOINT POWER ALLIANCE (NJPA) COOPERATIVE PURCHASING SYSTEM

WHEREAS, the City of Woodbury is in need of a Wood Chipper; and

WHEREAS, pursuant to Resolution No. 16-116, the City of Woodbury is a member of the National Joint Powers Alliance (NJPA) Cooperative Purchasing System; and

WHEREAS, N.J.S.A. 52:34-6.2, as amended by P.L. 2011, c.139, authorizes the City to purchase goods or to contract for services through the use of a nationally-recognized and accepted cooperative purchasing system that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the nationally-recognized National Joint Powers Alliance ("NJPA") cooperative purchasing system, located in Minnesota, offers voluntary participation in its cooperative purchasing system for the purchase of goods and services from NJPA vendors; and

WHEREAS, the City of Woodbury wishes to purchase the following items through the NJPA vendor, Vermeer North Atlantic, Lumberton New Jersey:

Vermeer BC1500 130 HP Wood Chipper

WHEREAS, purchases through NJPA comply with the Local Public Contract Law Requirements; and

WHEREAS, the CFO has certified the availability of funds for such purchases.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Woodbury, the Mayor concurring, that the Mayor, Administrator and/or CFO are hereby authorized to execute such documents as necessary to effectuate the purchase of the above-referenced Wood Chipper through NJPA for a total purchase price not-to-exceed \$56,633.00.
