**RESOLUTION OF THE CITY OF WOODBURY AUTHORIZING RELEASE
OF THE PERFORMANCE GUARANTEE AND ACCEPTING THE
MAINTENANCE BOND OF GERALD A. BARRETT, LLC
REGARDING THE FY2015 NJDOT LOCAL AID PROJECT
WEST BARBER AVENUE MILLING & OVERLAY**

WHEREAS, Gerald A. Barrett, LLC posted a Performance Guarantee, for the project known as FY2015 NJDOT Local Aid Project – West Barber Avenue Milling & Overlay, hereinafter “Project”; and

WHEREAS, Federici & Akin, City Engineer on the Project, by letter of October 3, 2016, recommends release of the Performance Guarantee by correspondence contingent upon the posting of a Maintenance Guaranty in a form acceptable to the City Solicitor to be held for a period of one (1) year; and

WHEREAS, Gerald A. Barrett, LLC has posted Hudson Insurance Company Maintenance Bond No. ASA1783-7976MNT in the amount of \$177,645.76 for a period of two (2) years commencing September 9, 2016; and

WHEREAS, Federici & Akin, City Engineer on the Project, and Angelini Viniar & Freedman, City Solicitor, recommend acceptance of the Maintenance Bond for the project; and

WHEREAS, Federici & Akin, City Engineer on the Project, recommends release of the retainer held by the City of Woodbury in the amount of \$2,963.24 to Gerald A. Barrett, LLC.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury, County of Gloucester and State of New Jersey on this 11th day of October, 2016, that:

1. The Performance Guaranty posted by Gerald A. Barrett, LLC for the project known as FY2015 NJDOT Local Aid Project – West Barber Avenue Milling & Overlay, is hereby released; and

2. The Maintenance Bond being Hudson Insurance Company Maintenance Bond No. ASA1783-7976MNT posted by Gerald A. Barrett, LLC for the project known as FY2015 NJDOT Local Aid Project – West Barber Avenue Milling & Overlay in the amount of \$177,645.76, is hereby accepted; and

3. The Retainer held by the City of Woodbury in the amount of \$2,963.24, is hereby released to Gerald A. Barrett, LLC
