

RESOLUTION #17-61

**RESOLUTION AWARDING CONTRACT TO GERALD A. BARRETT, LLC
FOR THE FY2016 NJDOT LOCAL AID PROJECT
TATUM STREET MILLING & OVERLAY
WEST RED BANK AVENUE TO WATKINS AVENUE – PHASE 1
PROGRESS AVENUE TO HESSIAN AVENUE – PHASE 2**

WHEREAS, the City of Woodbury advertised for bids for the FY2016 NJDOT Local Aid Project - Tatum Street Milling & Overlay - West Red Bank Avenue to Watkins Avenue – Phase 1 and Progress Avenue to Hessian Avenue – Phase 2, the “Project”; and

WHEREAS, the City of Woodbury received nine (9) bids on February 22, 2017, with the three (3) low bids set forth below:

WHEREAS, the City Engineer has reviewed the bids and by correspondence dated February 22, 2017 has recommended award of the Contract for the base bid and Alternate No. 1 only due to the amount of available grant funds being on \$212,320.00; and

WHEREAS, Gerald A. Barrett, LLC, is the low bidder for the base bid and Alternate No. 1 in the amount of \$194,530.86; and

WHEREAS, the low bid is compliant in all material non-waivable respects and the amount is consistent with the Engineer’s Estimate; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Woodbury that:


1. The contract is hereby awarded to Gerald A. Barrett, LLC for the FY2016 NJDOT Local Aid Project - Tatum Street Milling & Overlay - West Red Bank Avenue to Watkins Avenue – Phase 1 and Progress Avenue to Hessian Avenue – Phase 2 in the amount of \$194,530.86, including the base bid and Alternate No. 1 only, subject to the approval of the NJDOT.

2. That the Mayor and/or Administrator is hereby authorized to execute a contract in accordance with the bid specifications, the afore-described bid, and the within Resolution.
