## RESOLUTION OF THE CITY OF WOODBURY AUTHORIZING RELEASE OF THE PERFORMANCE GUARANTEE AND ACCEPTING THE MAINTENANCE BOND OF FAST PIPE LINING EAST, INC. REGARDING THE FY2016 SANITARY SEWER LINING PROJECT

WHEREAS, Fast Pipe Lining, East, Inc. posted a Performance Guaranty, being Hudson Insurance Company Bond No. ASA 1851-8958, for the project known as FY2016 Sanitary Sewer Lining Project along Evergreen Avenue and Tatum Street; and

WHEREAS, Federici & Akin, City Engineer on the Project, and Angelini Viniar & Freedman, City Solicitor, recommend acceptance of the Maintenance Bond for the project; and WHEREAS, Federici & Akin, City Engineer on the Project, recommends release of the retainer held by the City of Woodbury in the amount of \$7,003.68 to Fast Pipe Lining, East, Inc.

- 3. The Retainer held by the City of Woodbury in the amount of \$7,003.68, is hereby released to Fast Pipe Lining, East, Inc.
