Conversation continued involving questions regarding the monetary figures; and Mayor Floyd had some questions regarding the City's position on certain action being considered this evening. City Solicitor stated he would prefer to answer those questions in closed session. On advice from the City Solicitor, Councilman Fleming amended his motion to table the resolution; but only until Council had an opportunity to go into Closed Session to hear what the Solicitor's recommendations were before making a final decision on adopting Resolution #17-172 this evening, motion seconded by Councilwoman Tierney. Councilwoman Tierney made a motion to add a Resolution for a Closed Session this evening, to discuss the property and possible litigation, seconded by Councilman Fleming. Councilman Johnson stated he attended a Creative Team Meeting where they discussed the following: Chamber of Commerce raised \$197,000 at the recent Dancing with the Stars Event and another fund raiser at Auletto's on November 15th at 5:30 pm. Over the past twelve years they have raised 1.5 million dollars from this event; WORC raised \$10,000 which will be used for another home improvement project, they are also holding a fund raiser at Eight and Sand,

new planters along Broad Street will be installed, on Nov. 12th ·FAF is looking into holding more events at Lot 323 and reported that the average attendance was 300/500 people, Main Street Ghost Tours on Friday, Oct. 27th starting at 6:00 pm, Tiki Tiki is having a movie the same night as the Ghost Tours, Community Garden is looking for more volunteers and hoping to get high school students involved, Hispanic Center recently held a Health Fair last Saturday, the NAACP held their Annual Banquet and presented him with a "Game Changer Award". Also there will be a Grand Opening of the new concession stand at Stewart Lake Park this Saturday, October 28th.

Councilwoman Tierney advised that the Property Maintenance Committee met last week and is happy to report that Sgt. Pitzo is doing a great job with property maintenance issues.

Report of the Mayor

Mayor Floyd stated she also attended the Hispanic Health Fair this past weekend. The Center is a great part of our community. She also thanked Community Gardens for all their hard work as well.

Department Announcements

City Administrator, Scott Carew advised that we have completed all paperwork to Classic Towns and look forward to what they have to offer us. He also referenced the Grand Opening of Girlz Time Spot Party Boutique, which recently opened last Saturday. Mr. Carew also advised that he continues to meet with Councilmembers and members of FAF to discuss possible uses for the area at 115 S. Broad Street.

Police Chief, Tom Ryan stated that the Prosecutor's Office opened a CAC Children's Advocacy Center this week where children can go to as a safe place to talk to people if they have been abused. He also advised that Trick or Treat Safety precautions will be listed on our website.
