**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY

WHEREAS, the City of Woodbury was awarded a Green Acres grant Project Number 0822-17-048 for the project Playground and Pavilion Plaza at Stewart Lake Park; and

WHEREAS, the City has determined that the purchase of the below listed equipment through MRC Recreation in accordance with Game Time quote number 135056 in the total amount of \$71,171.01 was the agreement that best meets the needs of the City with respect to the purchase of playground equipment; and
