**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY
AWARDING CONTRACT TO RICKY SLADE CONSTRUCTION, INC. FOR THE
FY2017 LOCAL ROADS RESURFACING PROJECT WALNUT STREET, CHESTNUT
STREET, CHERRY STREET, HUNTER STREET AND OLD POLICE STATION
PARKING LOT**

WHEREAS, the City Engineer received three (3) bids on January 11, 2018 for FY2017 Local Roads Resurfacing Project – Walnut Street, Chestnut Street, Cherry Street, Hunter Street and old Police Station Parking Lot, the “Project”, as set forth below:

WHEREAS, the City Engineer has reviewed the bids received and by correspondence dated January 16, 2018, has recommended award of the Contract to Ricky Slade Construction, Inc., in the amount of \$213,888.00; and

WHEREAS, the low bid is compliant in all material non-waivable respects and the amount is consistent with the Engineer’s Estimate; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Woodbury that:

1. The contract is hereby awarded to Ricky Slade Construction, Inc. for FY2017 Local Roads Resurfacing Project – Walnut Street, Chestnut Street, Cherry Street, Hunter Street and old Police Station Parking Lot in the amount of \$213,888.00.
2. That the Mayor and/or Administrator is hereby authorized to execute a contract in accordance with the project specifications, the afore-described quote, and the within Resolution.
