**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE PURCHASE OF A TRASH TRUCK THROUGH NATIONAL
JOINT POWER ALLIANCE (NJPA) COOPERATIVE PURCHASING SYSTEM**

WHEREAS, the City of Woodbury is in need of a 20 Yard Rear Loader Trash Truck;
and

WHEREAS, pursuant to Resolution No. 16-116, the City of Woodbury is a member of
the National Joint Powers Alliance (NJPA) Cooperative Purchasing System; and

WHEREAS, N.J.S.A. 52:34-6.2, as amended by P.L. 2011, c.139, authorizes the City to
purchase goods or to contract for services through the use of a nationally-recognized and
accepted cooperative purchasing system that has been developed utilizing a competitive bidding
process by another contracting unit within the State of New Jersey, or within any other state,
when available; and

WHEREAS, the nationally-recognized National Joint Powers Alliance (“NJPA”)
cooperative purchasing system, located in Minnesota, offers voluntary participation in its
cooperative purchasing system for the purchase of goods and services from NJPA vendors; and

WHEREAS, the City of Woodbury wishes to purchase the following items through the
NJPA vendor, Scranton Manufacturing Co., Inc., AKA New Way Trucks, 101 State Street, PO
Box 336, Scranton, IA 51462:

2019 Western Star Chassis with 20 Yard New Way Rear Loader Trash Truck

WHEREAS, the CFO has certified the availability of funds for such purchases, under
Bond Ordinance 2266-17, budget account C-04-17-266-020 in the amount of \$119,289.00 and
Bond Ordinance 2249-16, budget account C-04-16-249-020 in the amount of \$59,887.00 and
budget account 8-01-26-305-220 in the amount of \$5,052.12;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Woodbury,
the Mayor concurring, that the Mayor, Administrator and/or CFO are hereby authorized to
execute such documents as necessary to effectuate the purchase of the above-referenced Trash
Truck through NJPA for a total purchase price not-to-exceed \$184,228.18.
