**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY  
AUTHORIZING THE PURCHASE AND INSTALLATION OF PLAYGROUND  
EQUIPMENT FOR LAFAYETTE PARK AKA SUITER BAPTISTE PARK**

**WHEREAS**, the City of Woodbury was awarded a Community Development Block Grant (CDBG) Agreement No. CD-17-MP7 for the Neighborhood Park Improvements to Lafayette Park aka Suiter Baptiste Park; and

**WHEREAS**, the City has determined that the purchase of the below listed equipment through MRC Recreation in accordance with Game Time quote number 137996 in the total amount of \$20,656.32 was the agreement that best meets the needs of the City with respect to the purchase of playground equipment; and

Game Time Custom Prime Time Unit  
GT-Impax – 1008 SF of Engineered Wood Fiber @8” Depth  
Game Time – Geo-Textile 2250 Sq ft Roll  
Game Time – Sitting See Saw

**WHEREAS**, the purchase agreement for the playground equipment is not subject to the mandatory bid requirements for municipalities in the State of New Jersey, as having been procured pursuant to State Contract 16-FLEET-00121, including all requirements contained therein and under law; and

**WHEREAS**, the City has determined that the purchase of the below listed equipment through RubbeRecycle in accordance with PlaySafer quote in the total amount of \$2,138.00 was the agreement that best meets the needs of the City with respect to the purchase of playground equipment; and

Supply only of (24) 6’ Long 8” High Rubber Play Curbs to enclose Playground. 132 LF total.

**WHEREAS**, the purchase agreement for the playground equipment is not subject to the mandatory bid requirements for municipalities in the State of New Jersey, as having been procured pursuant to State Contract 16-FLEET-00131, including all requirements contained therein and under law; and

**WHEREAS**, the City has received quotes for the installation of the Game Time playground equipment, wood fiber and rubber play curbs listed above, with pricing based on NJ prevailing wage rates, in the following amounts:

Whirl Construction, Inc.	\$7,673.00
A2H Construction	\$7,930.00

**WHEREAS**, the City has determined that the lowest responsible quote for the installation of the above mentioned equipment is While Construction, in the amount of \$7,673.00.

**WHEREAS**, the Chief Financial Officer has certified that funds are available for this purchase under the CDBG Grant in the amount of \$30,000 and City budget line item C-04-17-266-030 in the amount of \$467.32.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Woodbury, the Mayor concurring, that Jessica Floyd, Mayor and Daneen Fuss, City Clerk are hereby authorized to execute the


purchase agreement with MRC Recreation for the equipment described above in the amount of \$20,656.32.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Woodbury, the Mayor concurring, that Jessica Floyd, Mayor and Daneen Fuss, City Clerk are hereby authorized to execute the purchase agreement with Whirl Construction, Inc. for the installation described above in the amount of \$7,673.00.
