

ORDINANCE NO. 2284-18

**ORDINANCE AMENDING CHAPTER 84 "FEES" OF
THE CODE OF THE CITY OF WOODBURY**

WHEREAS, staff has recommended updating the fees for the Vital Statistics Office to provide certified copies of various records; and

WHEREAS, the fee revisions are modest and Mayor and Council wish to adopt same;

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the City of Woodbury that Woodbury City Code Chapter 84-1B. (1), of the Code of the City of Woodbury, shall be **AMENDED** and shall henceforth read in its entirety as follows:

§84-1B. Vital Statistics office:

- (1) Certified copies of:
 - (a) Birth certificate:
 - [1] First copy: \$25
 - [2] All other copies: \$5
 - (b) Death certificate:
 - [1] First copy: \$25 .
 - [2] All other copies: \$5 .
 - (c) Marriage/civil union certificate:
 - [1] First copy: \$25
 - [2] All other copies: \$5
 - (d) Domestic partnership certificate:
 - [1] First copy: \$25
 - [2] All other copies: \$5


BE IT FURTHER ORDAINED that all other sections of Chapter 84 shall remain in full force and effect.

BE IT FURTHER ORDAINED to the extent that any portion of the within Ordinance is declared in any way unenforceable same shall not affect the remaining provisions in this Ordinance.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon passage and publication as required by law.

THE FOREGOING was introduced by the City Council of the City of Woodbury at a regular meeting held on May 8, 2018. This Ordinance will be considered for adoption at final reading and public hearing to be held on May 22, 2018 at 7:00 p.m. or at such time as may be determined and announced, in City Hall, Council Chambers, 33 Delaware Street, Woodbury, New Jersey, at which time and place all persons interested will be given the opportunity to be heard concerning said Ordinance. During the time prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the City Clerk's Office to the members of the general public who may request same.


