

RESOLUTION NO. 18-107

RESOLUTION OF THE CITY OF WOODBURY APPROVING A SHARED SERVICES AGREEMENT WITH THE COUNTY OF GLOUCESTER FOR THE PROVISION OF FAMILY ENTERTAINMENT

WHEREAS, the County of Gloucester (“County”) historically provides family-oriented amusements, such as shows, concerts, skits and the like, particularly during the mild weather months, to enhance the quality of life by offering wholesome entertainment; and

WHEREAS, the City of Woodbury (“City”) is desirous of permitting the County to use a field located in the City for the performance of *88 MPH (Band)* to perform on Saturday, June 30, 2018 at 7:00 p.m., with a rain date of Sunday, July 1, 2018; and

WHEREAS, the City is desirous of permitting the County to use Wing-Dickerson Park, for the showing of a recently released family-oriented movie to be shown, weather permitting, at dusk, on Friday, June 29, 2018, with a rain date of Saturday, June 30, 2018; and

WEHREAS, the City is willing and able to permit the County to use specified areas in the City at no cost to the County in accordance with the Shared Services Agreement attached hereto and made a part of this Resolution; and


WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, *et seq.*, specifically authorizes local government units, including counties and municipalities, to enter into agreements for the provision of shared services;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury that the Mayor is hereby authorized to execute a Shared Services Agreement with the County of Gloucester for such services in the form agreement attached hereto.
