

ORDINANCE NO. 2290-18

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AMENDING CHAPTER 190 VEHICLES AND TRAFFIC
OF THE CODE OF THE CITY OF WOODBURY**

WHEREAS, the Mayor and City Council have determined that the following amendments to Chapter 190 Vehicles and Traffic, Sections 190-31 and 190-34, Article XII: Schedules of the Code of the City of Woodbury will promote the health, safety and welfare of the citizens of the City of Woodbury.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and City Council of the City of Woodbury that Chapter 190-31, Article XII, Schedule I: No Parking, shall be amended to **ADD** the following:

Name of Street	Side	Location
East Barber Avenue	North	From Franklin Street to South Broad Street

BE IT FURTHER ORDAINED, by the Mayor and City Council of the City of Woodbury that Chapter 190-34, Article XII, Schedule IV: Time Limit Parking of the Code of the City of Woodbury shall be amended to **REMOVE** the following:

Name of Street	Side	Hours	Maximum Time	Location
East Barber Avenue	North	8:00 a.m. to 12:00 midnight	120	From Franklin Street to South Broad Street

BE IT FURTHER ORDAINED that all other provisions of said Ordinance not specifically amended herein shall remain in full force and effect and any ordinances inconsistent herewith are repealed to the extent of any inconsistency.


BE IT FURTHER ORDAINED that any portion of the within Ordinance is deemed invalid by a court of competent jurisdiction, same shall not affect the remaining portions of the within Ordinance.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage, approval and publication as required by law.

THE FOREGOING was introduced by the City Council of the City of Woodbury at a regular meeting held on August 14, 2018. This Ordinance will be considered for adoption at final reading and public hearing to be held on September 11, 2018 at 7:00 p.m. or at such time as may be determined and announced, in City Hall, Council Chambers, 33 Delaware Street, Woodbury, New Jersey, at which time and place all persons interested will be given the opportunity to be heard concerning said Ordinance. During the time prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the City Clerk's Office to the members of the general public who may request same.


