

RESOLUTION NO. 18-145

**RESOLUTION AUTHORIZING THE PURCHASE OF AN STUMP CUTTER
THROUGH NATIONAL JOINT POWER ALLIANCE (NJPA) COOPERATIVE
PURCHASING SYSTEM**

WHEREAS, the City of Woodbury is in need of a Stump Cutter for the purpose of tree maintenance performed by the Public Works Department; and

WHEREAS, pursuant to Resolution No. 16-116, the City of Woodbury is a member of the National Joint Powers Alliance (NJPA) Cooperative Purchasing System; and

WHEREAS, N.J.S.A. 52:34-6.2, as amended by P.L. 2011, c.139, authorizes the City to purchase goods or to contract for services through the use of a nationally-recognized and accepted cooperative purchasing system that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the nationally-recognized National Joint Powers Alliance ("NJPA") cooperative purchasing system, located in Minnesota, offers voluntary participation in its cooperative purchasing system for the purchase of goods and services from NJPA vendors; and

WHEREAS, the City of Woodbury wishes to purchase the following items through the NJPA vendor, Vermeer Sourcewell, and their local dealerships, under the Contract #062117-VRM:
SC802 – 74hp Stump Cutter

WHEREAS, purchases through NJPA comply with the Local Public Contract Law Requirements; and


WHEREAS, the Chief Financial Officer has certified that funds are available for this purchase under the City bond ordinance 2288-18 (C-04-18-288-040);

FLOYD, Mayor and DANEEN FUSS, City Clerk are hereby authorized to execute such documents as necessary to effectuate the purchase of the above-referenced Stump Cutter through NJPA for a total purchase price not-to-exceed \$51,948.00.
