

RESOLUTION NO. 18-162

RESOLUTION AUTHORIZING THE PURCHASE OF A KUBOTA TRACTOR THROUGH THE NATIONAL JOINT POWER ALLIANCE (NJPA) COOPERATIVE PURCHASING SYSTEM AKA SOURCEWELL

WHEREAS, the City of Woodbury is in need of a Kubota Tractor as equipment needed for use by the Public Works Department; and

WHEREAS, pursuant to Resolution No. 16-116, the City of Woodbury is a member of the National Joint Powers Alliance (NJPA) Cooperative Purchasing System; and

WHEREAS, N.J.S.A. 52:34-6.2, as amended by P.L. 2011, c.139, authorizes the City to purchase goods or to contract for services through the use of a nationally-recognized and accepted cooperative purchasing system that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the nationally-recognized National Joint Powers Alliance (“NJPA”) cooperative purchasing system, located in Minnesota, offers voluntary participation in its cooperative purchasing system for the purchase of goods and services from NJPA vendors; and

WHEREAS, the City of Woodbury wishes to purchase the following items through the NJPA vendor, Kubota Tractor Corporation, and their authorized local dealership, Cherry Valley Tractor Sales, Inc., Marlton NJ, under the Contract # 042815-KBA:

M62TLB-LB – 4WD Tractor Loader Backhoe w/Loader and Backhoe Remote Valve

WHEREAS, purchases through NJPA comply with the Local Public Contract Law Requirements; and


WHEREAS, the Chief Financial Officer has certified that funds are available for this purchase under the City bond ordinance 2289-18 (C-10-18-289-050) in the amount of \$75,000.00 and Utility Operating Budget account 8-09-55-502-201, in the amount of \$5,040.56;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Woodbury, that JESSICA M. FLOYD, Mayor and DANEEN FUSS, City Clerk are hereby authorized to execute such documents as necessary to effectuate the purchase of the above-referenced Kubota Tractor through NJPA/Sourcewell for a total purchase price not-to-exceed \$80,040.56.
