

RESOLUTION NO. 18-168

RESOLUTION OF THE CITY OF WOODBURY REFERRING THE MATTER OF AN ORDINANCE TO REGULATE ROLL DOWN SECURITY GRATES ON LOCAL BUSINESSES TO THE CITY OF WOODBURY PLANNING BOARD FOR REVIEW AND RECOMMENDATION PURSUANT TO *N.J.S.A. 40:55D-26*

WHEREAS, the City of Woodbury Planning Board has requested Mayor and Council to consider regulations of roll down security grates at local businesses; and

WHEREAS, there is a concern that utilization by a large number of businesses of pull down security grates subliminally injects a chilling impact to shoppers and implants a less than welcome atmosphere in the City of Woodbury; and

WHEREAS, the City of Woodbury Planning Board has requested guidance in this regard; and

WHEREAS, the Mayor and City Council wish to refer the matter to the City of Woodbury Planning Board as required by the Municipal Land Use Law for review, preparation of a report, and recommendation of an Ordinance to regulate roll down security grates at local businesses.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury that pursuant to *N.J.S.A. 40:55D-26* the City of Woodbury Planning Board review and make a recommendation to the Mayor and Council of an Ordinance to regulate roll down security grates and to prepare and submit to the Mayor and Council a report including identification of any provisions in the Ordinance which are inconsistent with the Master Plan and recommendations concerning any such inconsistencies and any other matter as the Board deems appropriate pursuant to *N.J.S.A. 40:55D-26* and for specific review by the Board and report to the Mayor and Council as to whether said Ordinance is substantially consistent with the Land Use Plan Element and the Housing Plan Element of the Master Plan or designed to effectuate such Plan Elements.

ADOPTED at a regular meeting of the Mayor and City Council of the City of Woodbury on October 9, 2018.
