**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT
FOR COMPUTER CONSULTING SERVICES
FOR THE WOODBURY POLICE DEPARTMENT**

WHEREAS, the City of Woodbury has a need to acquire the services of a Computer Consultant for the City of Woodbury Police Department for the year 2019 as a non-fair and open contract pursuant to the provisions of *N.J.S.A. 19:44A-20.5*; and

WHEREAS, Premier Technology Solutions has submitted a proposal indicating they will provide Computer Consultant Services to the City of Woodbury Police Department; and

WHEREAS, Premier Technology Solutions has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the City of Woodbury in the previous one year, and that the contract will prohibit Premier Technology Solutions from making any reportable contributions through the term of the contract, and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds to award such contract; and

WHEREAS, the Chief Financial Officer has determined and certified in writing that the value of the acquisition may exceed \$17,500.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the City of Woodbury authorizes the Mayor and/or City Administrator to enter into a professional services contract with Premier Technology Solutions as described herein in accordance with the proposal; and,

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution; and,


BE IT FURTHER RESOLVED that a notice of this resolution shall be published in the South Jersey Times as required by law within ten (10) days of its passage.
