**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
APPOINTING JOHN LEECH AS EMERGENCY MANAGEMENT COORDINATOR,  
AND JOSEPH BUONO AND WILLIAM PALESE AS DEPUTY EMERGENCY  
MANAGEMENT COORDINATORS FOR  
THE CITY OF WOODBURY**

**WHEREAS**, the City of Woodbury is in need of an Emergency Management Coordinator and Deputy Emergency Management Coordinators; and

**WHEREAS**, John Leech has the requisite skills and experience to serve as Emergency Management Coordinator for the City of Woodbury; and

**WHEREAS**, Joseph Buono and William Palese have the requisite skills and experience to serve as Deputy Emergency Management Coordinators for the City of Woodbury; and

**WHEREAS**, the Deputy Emergency Management Coordinators shall operate under the command of the Emergency Management Coordinator for the City of Woodbury; and

**WHEREAS**, the Deputy Emergency Management Coordinators shall operate as Emergency Management Coordinator for the City of Woodbury in the absent of John Leech; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Woodbury, that

1. John Leech is hereby appointed the City of Woodbury Emergency Management Coordinator for a term of three (3) years, effective immediately and at a salary of \$5,000 annually.
2. Joseph Buono is hereby appointed the City of Woodbury Deputy Emergency Management Coordinator for a term of three (3) years, effective immediately and at a salary of \$5,000 annually.

3. William Palese is hereby appointed the City of Woodbury Emergency Management Coordinator for a term of three (3) years, effective immediately and at a salary of \$5,000 annually.
