ORDINANCE 2307-19

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY,
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AMENDING CHAPTER 162
ENTITLED “SOLID WASTE” OF THE CODE OF THE CITY OF WOODBURY**

WHEREAS, the Mayor and Council of the City of Woodbury have determined that certain amendments to Chapter 162 entitled “**Solid Waste**” are necessary; and

WHEREAS, in all other respects Chapter 162 entitled “Solid Waste” shall remain in full force and effect.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the City of Woodbury, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

Section 1

Section 162-11 entitled “Preparation of garbage and refuse for collection” be amended to add as follows:

§162-11. Preparation of garbage and refuse for collection.

The occupant or owner of any building within the City of Woodbury who shall place for disposal, removal or collection the following named items shall do so in strict conformity with the following regulations:

- A. Trash cans must have a lid and cannot exceed 50 lbs.
- B. Trash, debris and garbage shall be placed in plastic bags securely tied, with a total weight not to exceed 50 pounds.
- C. Plastic containers, paper products, glass and aluminum items shall be placed the reusable receptacle supplied by the City of Woodbury.
- D. Brush. Branches shall be tied in bundles not to exceed four feet in length and of sufficient size and weight, not to exceed 50 pounds, to be handled by one person.
- E. Large nonmetal items provisions are as follows:
 - [1] Upholstered furniture, box springs, and mattresses are to be placed in plastic bags and sealed or wrapped in plastic and securely taped so that the contents are fully enclosed.
 - [2] Rugs are to be cut into 5 foot lengths, rolled and securely taped or tied.
 - [3] Television sets and tires, shall be placed at curbside on the day designated for collection of such items.
 - [4] Syringes needles must be broken off and both parts must be placed inside a sealed heavy container and disposed of with the trash.
- F. Yard and tree refuse. Grass clippings, lawn thatchings and leaves shall be placed

separately in reusable containers.

- G. Nothing in this subsection shall prevent the hiring of a private contractor for removal or collection of trash, debris or garbage, provided that proper collection vehicles or receptacles are used. Such receptacle shall have affixed or painted upon it the identity of the party which has contracted for such service. Such party shall be responsible for the placement and maintenance of the receptacle and maintenance of the surrounding area.

Section 162-13 entitled "Placement of receptacles for collection" shall be amended as follows:

§162-13. Placement of receptacles for collection.

Trash receptacles required herein shall be supplied by the occupant and/or owner of the premises. Recycling receptacles are supplied by the City of Woodbury. Both receptacles are to be placed prior to collection between the curb and sidewalk where they shall be readily accessible to the collector. The owner and/or occupant shall keep all receptacles clean and in condition for safe holding. The following regulations shall apply to the placement and removal of receptacles.

- A. No receptacle or other items to be disposed may be placed in front of the premises for pick up prior to 5:00 p.m. of the day immediately preceding the day of collection.
- B. Upon collection, all receptacles or containers shall be removed no later than 7:00 p.m. of the scheduled day of collection.
- C. All receptacles, when not placed for curbside collection, shall be located to the rear of the property and shall not be subject to public view from the front of the property.
- D. The owner or occupant of any property, or any employee or contractor of such owner or occupant engaged to provide lawn care or landscaping services, shall not sweep, rake, blow or otherwise place yard waste, unless the yard waste is containerized, in the street. If yard waste that is not containerized is placed in the street, the party responsible for placement of yard waste must remove the yard waste from the street or said party shall be deemed in violation of this article.
- E. Sweeping, raking, blowing or otherwise placing yard waste that is not containerized must be placed in the right of way between the curb and the sidewalk is only allowed during the seven days prior to a scheduled and announced collection and shall not be placed closer than 10 feet from any storm drain inlet. Placement of such yard waste in the right of way between the curb and the sidewalk at any other time or in any other manner is a violation of this article. If such placement of yard waste occurs, the party responsible for placement of the yard waste must remove the yard waste from the area shall be deemed in violation of this article.
- F. Penalties:
 - (1) The penalty for failure to comply with the prescribed times for placement or

removal of a receptacle shall be as follows:

- (a) First violation: Written warning.
- (b) Second and additional violations: As prescribed by § 162-16.

(2) All fines may be made payable through the Municipal Violations Clerk.

G. The owner and/or occupant shall be individually or jointly responsible for compliance with the provisions of this section.

Section 162-15 entitled “Responsibility of contractors for hire” shall be amended as follows:

§162-15. Responsibility of contractors for hire.

- A. All construction debris and/or trade waste arising from work performed by a contractor for hire shall be the sole responsibility of such contractor, and not the City of Woodbury.
- B. All construction debris and/or trade waste shall be removed by the contractor for hire within 15 days of work completion.
- C. Nothing herein shall be interpreted to preclude the pickup of construction debris and/or waste generated by work physically performed by a resident at the property which he or she owns or in which he or she resides in the City of Woodbury. However, the owner or occupant must make arrangements with the City of Woodbury Public Works Department to have the debris removed.

Section 2.

Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3.

Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
