

**RESOLUTION NO. 19-74**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
APPROVING THE SUBMISSION OF A GRANT APPLICATION AND THE  
EXECUTION A GRANT AGREEMENT WITH THE NEW JERSEY DEPARTMENT  
OF TRANSPORTATION FOR THE 2019 LOCAL AID INFRASTRUCTURE FUND  
PROJECT HEREINAFTER KNOWN AS SOUTH GIRARD STREET  
RESURFACING**

**WHEREAS**, The City of Woodbury is in need of resurfacing the roadway, including milling and overlay, removal of curb barriers at intersections, installation of bicycle-safe inlet grates, and replacing damaged or missing concrete curbing along South Girard Street from Prince Street to Myrtle Avenue, and replacing the culvert at the head of Bell Lake; and

**WHEREAS**, the City Engineer has estimated the construction cost of the necessary improvements at approximately \$345,575 plus \$86,380 for construction management & inspection services, plus \$2,000 for materials testing for a total amount of \$433,955; and

**WHEREAS**, The City of Woodbury desires to prepare plans and specifications and to issue bid documents for construction in 2019, as funds become available.

**NOW, THEREFORE, BE IT RESOLVED**, that Council of the City of Woodbury understands that the South Girard Street Resurfacing Project will be constructed in 2019, and the City of Woodbury formally approves the grant application for the above-stated project; and

**BE IT FURTHER RESOLVED**, that the Mayor, City Administrator, Treasurer, City Clerk, and City Engineer are hereby authorized to submit an electronic grant application identified as Application No. LAIF-2019-South Girard Street-00057 to the New Jersey Department of Transportation on behalf of the City of Woodbury; and

**BE IT FURTHER RESOLVED**, that the Mayor, City Administrator, Treasurer, and City Clerk are hereby authorized to sign the grant agreement on behalf of the City of Woodbury and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.


