**RESOLUTION OF THE CITY OF WOODBURY AUTHORIZING
CHANGE ORDER NO. 1 FOR THE LANDBERG CONSTRUCTION, LLC CONTRACT
FOR MILLING AND OVERLAY ON THE “WEST CENTRE STREET
RESURFACING” PROJECT REQUIRING EXTRA WORK FOR
REPLACEMENT OF MANHOLE FRAMES & LIDS**

WHEREAS, the City of Woodbury (Woodbury), with its principal place of business at 33 Delaware Street, Woodbury, New Jersey 08096 entered into a contract with Landberg Construction, LLC., of Dorothy, New Jersey under NJDOT Project No.: PRO-2018-West Centre Street-04582 for milling and overlay to West Centre Street for the City of Woodbury; and

WHEREAS, during the performance of this project it was determined extra work was required to replace the sewer manholes frames and lids with the required 30” diameter fixtures. The contract has a line item for this, but the work required removal of the top part of the brick manholes to fit the 30” frames on properly. The change order deducts the \$1,000 per the contract for 8 manholes and adds the \$2,200 for 7 manholes, a net increase of \$7,400; and

WHEREAS, Change Order No. 1, attached hereto and incorporated herein has been reviewed by the City of Woodbury project engineer Paul D. Breier, P.E., P.P. by email dated May 8, 2019 which is incorporated herein at length; and

WHEREAS, the value of Contract is now, as stated, and as a result of this Change Order No. 1, in the amount of \$315,976.82.

NOW, THEREFORE, BE IT RESOLVED, the City of Woodbury, does hereby authorize Change Order No. 1 to reflect the additional work required for the replacement of the frames and lids for the existing sanitary sewer manholes in order to meet OSHA standards for access to the manholes. Change Order No. 1 will increase the contract total by \$7,400.00 and the contract total including this Change Order is now \$315,976.82.
