

**ORDINANCE 2310-19**

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY,  
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AMENDING CHAPTER 190  
ENTITLED "VEHICLES AND TRAFFIC" OF THE CODE OF THE  
CITY OF WOODBURY**

**WHEREAS**, the Mayor and Council of the City of Woodbury have determined that certain amendments to Chapter 190 entitled "**Vehicles and Traffic**" are necessary; and

**WHEREAS**, in all other respects Chapter 190 entitled "Vehicles and Traffic" shall remain in full force and effect.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the City of Woodbury, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

**Section 1.** Chapter 190-47. Is hereby amended to read as follows (amendment in boldface):

Name of Street	Speed limit (mph)	Location
Along Delaware Street - Cooper Street	25	From West Deptford Township-City of Woodbury Corporate Line to Laurel Avenue
Along Delaware Street - Cooper Street	25	From Laurel Avenue to Evergreen Avenue
Along Delaware Street - Cooper Street	25	From Evergreen Avenue to Deptford Township-City of Woodbury Corporate Line

**Severability.**

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**Repealer.**


All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

**When effective.**


This Ordinance shall take effect immediately upon final passage and publication in accordance with law.


