

RESOLUTION NO. 19-116

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING EMERGENCY FUNDS FOR REPAIRS TO A SINK HOLE ON ALLEN
STREET; STORMDRAIN PIPE ON SOUTH BARBER AVENUE; STORMDRAIN
PIPE ON SOUTH WARNER AND SOUTH HORACE STREET AND
ADDITIONAL STREET REPAIRS**

WHEREAS, on June 20, 2019 there was a storm event which caused flash flooding throughout the City of Woodbury; and

WHEREAS, a twelve (12') foot sink hole was created which compromised an underground twelve (12") pipe located on Allen Street requiring immediate repair; and

WHEREAS, it was discovered that a thirty-six (36") storm drainpipe was compromised on South Barber Avenue. This storm drainpipe runs under the railway tracks operated by Conrail requiring closure of South Barber Avenue and immediate repair; and

WHEREAS, on the corner of South Warner and South Horace Street, the thirty-six (36") storm drainpipe was compromised and requires immediate repair;


WHEREAS, as a result of the storm and flash flooding, the City continues to identify miscellaneous streets and locations throughout the City in need of emergent repair and/or attention; and

WHEREAS, the public bidding for the above repair work would take months to complete and would expose the residents and visitors to the City of Woodbury to potentially unsafe conditions.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodbury, the Mayor concurring, as follows:

1. The expenditure of emergency funds is required and hereby authorized without competitive bidding for necessary and emergent repairs as hereinbefore indicated.


