**RESOLUTION OF THE CITY OF WOODBURY AUTHORIZING
CHANGE ORDER NO. 1 FOR THE PIONEER PIPE CONTRACTORS, INC.
CONTRACT FOR THE "2018 WATER MAIN IMPROVEMENTS" PROJECT
REQUIRING EXTRA WORK FOR REPAVING OF GLOVER STREET FROM PENN
STREET TO SALEM AVENUE**

WHEREAS, the City of Woodbury (Woodbury), with its principal place of business at 33 Delaware Street, Woodbury, New Jersey 08096 entered into a contract with Pioneer Pipe Contractors, Inc., of Salem, New Jersey; and

WHEREAS, during the performance of this project it was determined extra work was required to adjust the contract amount and scope of work for the milling and paving of Glover Street in the area where the new water main and services were installed. Final construction quantities are also reconciled based on the actual work performed. The change order has a net increase of \$20,570.29; and


WHEREAS, Change Order No. 1, attached hereto and incorporated herein has been reviewed by the City of Woodbury project engineer Erika Vardaxis, P.E., P.P. by email dated July 18, 2019 which is incorporated herein at length; and

WHEREAS, the value of Contract is now, as stated, and as a result of this Change Order No. 1, in the amount of \$356,608.29.

NOW, THEREFORE, BE IT RESOLVED, the City of Woodbury, does hereby authorize Change Order No. 1 to reflect the additional work required for the repaving of the entirety of Glover Street from Penn Street to Salem Ave. Change Order No. 1 will increase the contract total by \$20,570.29 and the contract total including this Change Order is now \$356,570.29.
