

**RESOLUTION NO. 19-137**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
AUTHORIZING THE RENEWAL OF AN INTERCONNECTION AGREEMENT  
BETWEEN THE BOROUGH OF WESTVILLE AND THE CITY OF WOODBURY**

**WHEREAS**, the Water Supply Management Act Rules, *N.J.A.C. 7:19-6, et seq.* promulgated by the New Jersey Department of Environmental Protection (NJDEP) permit the interconnection of adjacent water supply systems; and

**WHEREAS**, the City of Woodbury, hereinafter the "City", and the Borough of Westville, hereinafter the "Borough", have for many years have had, and continue to have an Interconnect Agreement with one another, for the purpose of supplying potable water during emergency situations; and

**WHEREAS**, NJDEP rules, specifically *N.J.A.C. 7:19-6.9(g)* require that entities maintaining interconnected systems enter in a written agreement setting forth the conditions for use of the interconnection, which agreement must be filed with and approved by NJDEP; and

**WHEREAS**, a Water Supply Interconnection Agreement, hereinafter "Agreement" between the City and the Borough has been prepared and is attached hereto memorializing the conditions which have been understood and adhered to between the parties for many years in the event a water emergency exists by either party, all steps should be taken to protect their respective emergency in order to comply with the said NJDEP requirement for an approved written agreement; and

**WHEREAS**, the City and the Borough have reviewed the Agreement and desire to enter into same.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Woodbury that the Mayor and/or Administrator is hereby authorized to execute an Interconnection Agreement between the City of Woodbury and Borough of Westville for the purpose of supplying potable water during emergency situations, in the form agreement attached hereto.

**ADOPTED** at a regular meeting of the Mayor and City Council of the City of Woodbury on September 10, 2019.
