

RESOLUTION NO. 19 -141

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE NJDOT FINAL CHANGE ORDER FOR THE FY2018
MUNICIPAL AID PROJECT - WEST CENTRE STREET MILLING & OVERLAY
SOUTH DREXEL STREET TO SOUTH JACKSON STREET**

WHEREAS, the City of Woodbury (Woodbury), with its principal place of business at 33 Delaware Street, Woodbury, New Jersey 08096 entered into a contract with Landberg Construction, LLC., of Dorothy, New Jersey for the FY2018 NJDOT Municipal Aid Project - West Centre Street Milling and Overlay South Drexel Street to South Jackson Street, the "Project", by Resolution No. 18-173 for the contract amount of \$308,576.82 ; and

WHEREAS, the Final Change Order is required to reconcile the final quantity and cost of the contract pay items based on completion of all work done by the Contractor, as set forth in the attached final Change Order; and

WHEREAS, the final Contract price including the Final Change Order is \$354,623.05 resulting in an overall increase in the original contract price of 14.9%.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Woodbury that:

1. The Mayor is hereby authorized to execute the attached Final Change Order to the contract with Landberg Construction, LLC for the FY2018 NJDOT Municipal Aid Project - West Centre Street Milling and Overlay South Drexel Street to South Jackson Street; and
2. The City Engineer is hereby directed to seek reimbursement from the NJDOT Grant for the remaining construction costs up to the permitted amounts


