**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE IN THE  
BUDGET OF THE CITY OF WOODBURY PURSUANT TO  
N.J.S. 40A:4-87 (CHAPTER 159, P.L. 1948) – DISTRACTED DRIVING GRANT**

**WHEREAS**, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and

**WHEREAS**, said director may also approve the insertion of any item of appropriation for equal amount, and

**WHEREAS**, the City of Woodbury has received a \$6,600.00 Distracted Driving Mobilization grant from the NJ Division of Highway Traffic Safety for the period of April 1-21, 2019, and wishes to amend its 2019 budget to include this amount as revenue, and

**NOW, THEREFORE, BE IT RESOLVED** that the City of Woodbury, County of Gloucester, hereby requests that the Director of the Division of Local Government Services to approve the insertion of items of revenue in the budget year 2019 in the sum below, which item is now available as a revenue from: Special Item of Revenue Anticipated With Prior Written Consent of the Director of Local Government Services – Public and Private Revenues Offset with Appropriations:
