

RESOLUTION NO. 19-162

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING A PURCHASE AGREEMENT WITH CHERRY HILL WINNER
FORD FOR ONE 2020 POLICE VEHICLE**

WHEREAS, it was determined that there existed the need for one (1) additional police vehicle to supplement the existing fleet of the City of Woodbury Police Department, and

WHEREAS, it was determined that a purchase agreement with Cherry Hill Winner Ford, 250 Berlin Road, Cherry Hill, NJ 08034, for one (1) 2020 Ford Police Interceptor Utility All Wheel Drive vehicles for \$32,131.00 each, with accessories not-to-exceed \$22,771.30, for a total sum not-to-exceed \$54,902.30 for one (1) vehicle, was the agreement that best met the needs of the City with respect to the purchase of the vehicle, while still meeting the City's budgetary concerns; and

WHEREAS, the purchase agreement for this police vehicle is not subject to the mandatory bid requirements for municipalities in the State of New Jersey, as having been procured pursuant to State Contract #88728, including all requirements contained therein under law; and


WHEREAS, the Chief Financial Officer has certified that funds are available for this purchase under the City bond ordinance 2312-19 (C-04-18-288-060);

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Woodbury, that JESSICA M. FLOYD, Mayor and DANEEN FUSS, City Clerk are hereby authorized to execute the purchase agreement with Cherry Hill Winner Ford, for one (1) 2020 Ford Police Interceptor Utility All Wheel Drive vehicle for a total sum not-to-exceed \$54,902.30, as outlined above.
