**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE APPROVAL OF RIEHL'S TOWING COMPANY AS THE CITY
OF WOODBURY'S TOWING OPERATOR FOR A PERIOD OF THREE YEARS**

WHEREAS, pursuant to Chapter 182 of the Code of the City of Woodbury, applications for towing operators were received by the City; and

WHEREAS, said applications were reviewed by the Chief of Police for compliance with Chapter 182 and recommendation as to compliance and award were made to the City Clerk; and

WHEREAS, of the two applications submitted, the Chief of Police has found only the application of Riehl's Towing to be compliant with Chapter 182 and has recommended to the City Clerk approval of Riehl's Towing pursuant to Chapter 182; and


WHEREAS, the City Clerk concurs in the Chief's recommendation and recommends to the Mayor and Council approval of Riehl's Towing.
