**RESOLUTION AUTHORIZING EXECUTION OF CDBG AGREEMENT
WITH THE COUNTY OF GLOUCESTER AND ACCEPTANCE
OF \$50,000 CDBG BLOCK GRANT FUNDING**

WHEREAS, the City of Woodbury made application to the County of Gloucester for PY2019 Community Development Block Grant funds in the amount of \$50,000; and

WHEREAS, the purpose of the application for grant funds was for Reconstruction of South Maple Avenue including sidewalk/ADA curbs; and

WHEREAS, the City of Woodbury's application has been approved as project #CD-19-MP9, and the funds provided under the agreement must be fully expended by November 5, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury, that the Mayor and/or Administrator is hereby authorized to execute the attached Agreement for use of Community Development Block Grant Funds between Gloucester County, New Jersey and the City of Woodbury and to accept the Grant in the amount of \$50,000 for the specified purposes.
