

**RESOLUTION NO. 20-03**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
DESIGNATING A PRESIDENT "PRO TEMPORE" OF THE CITY COUNCIL WITH  
FULL AUTHORITY TO ACT IN ALL MATTERS AS THE PRESIDENT DURING THE  
COUNCIL PRESEDENT'S PERIODS OF ABSENCE**

**WHEREAS**, on occasions during the legislative year of 2020 because of the pressure of business or personal reasons, it is necessary that the President of City Council of the City of Woodbury, be absent from the City, therefore unable to attend a regular Council meeting during this period of absence; together with the duties and responsibilities granted by the City Charter and City Code; and

**WHEREAS**, it is the desire of the City Council of the City of Woodbury to provide for the orderly process of business that a President "pro tempore" be appointed with full authority to act in all matters as President of said City Council and as otherwise afforded by the City Charter and City Code; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Woodbury, the Mayor concurring, as follows:

1. That **COUNCILMAN PHILIP HAGERTY** be and is hereby designated as President "Pro Tempore" of the City Council of the City of Woodbury with all the authority, privileges and powers accorded by law to the President of Council during periods of absence, voluntary disqualifications or the temporary inability of the President of Council to be present at a Council meeting and in addition, together with all rights and responsibilities afforded the position pursuant to the City Charter and City Code.

2. This Resolution shall take effect immediately.
