

RESOLUTION NO. 20-53

A RESOLUTION OF THE CITY OF WOODBURY AUTHORIZING THE CITY TO ASSUME JURISDICTIONAL CONTROL OF A PORTION OF EAST BARBER AVENUE, SOUTH BARBER AVENUE, AND RAILROAD AVENUE IN THE CITY OF WOODBURY

WHEREAS, the County of Gloucester (hereinafter "County") has engaged in discussions with the City of Woodbury (hereinafter "City") regarding the County relinquishing jurisdictional control over three (3) portions of roadway, to the City of Woodbury, and both parties are in agreement; and


WHEREAS, the County approved Resolution #52024 on August 28, 2019, amended by Resolution #52110 on October 16, 2019, assuming jurisdictional control over the (3) portions of roadway located in the City of Woodbury.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodbury, County of Gloucester and State of New Jersey as follows:

1. That the City shall assume jurisdiction and control of the following portions of Roadway in the City of Woodbury already vacated by the County of Gloucester under Resolution #52024 on August 28, 2019 as amended by Gloucester County Resolution #52110 on October 16, 2019:
 - a. East Barber Avenue (CR 663) from State Highway Route 45 to Tanyard Road (CR 663).
 - b. South Barber Avenue (CR 649) from East Barber Avenue (CR 663) to Evergreen Avenue (CR 650).
 - c. Railroad Avenue (CR 708) from Cooper Street to East Barber Avenue (CR 663).

ADOPTED at the regular meeting of the Mayor and City Council of the City of Woodbury held on January 22, 2020.
