**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
APPOINTING MEMBERS TO THE DEPTFORD TOWNSHIP JOINT MUNICIPAL
COURT COMMITTEE**

WHEREAS, on November 10, 2014 the City of Woodbury passed Ordinance #2218-14 abolishing the City of Woodbury's Municipal Court effective February 9, 2015; and

WHEREAS, East Greenwich Township subsequently passed a mirror Ordinance; and

WHEREAS, on December 2, 2014, the City of Woodbury and the Township of East Greenwich both approved a Shared Services Agreement setting forth the operations of the East Greenwich Joint Municipal Court; and

WHEREAS, on December 11, 2018, the City of Woodbury adopted an ordinance #2301-18 authorizing the withdrawal by the city of woodbury from the Shared Service Agreement effective December 31, 2019; and

WHEREAS, East Greenwich Township subsequently passed a mirror Ordinance; and

WHEREAS, on December 10, 2019, the City of Woodbury adopted a Resolution 19-189 authorizing a Shared Service Agreement with the Township of Deptofor effective January 1, 2020; and

WHEREAS, said Shared Services Agreement creates a Joint Municipal Court Committee and provides for the appointment by the City of Woodbury and Township of Deptford of two (2) members each to the Deptford Township Joint Municipal Court Committee to carry out the functions of the Committee as defined in the Shared Services Agreement.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of Woodbury that WILLIAM FLEMING and FRANKLIN BROWN are hereby appointed to the Deptford Township Joint Municipal Court Committee for a term January 1, 2020 *nunc pro tunc* through December 31, 2020 who shall serve until their successors are appointed and qualified.

ADOPTED, at a meeting of the Mayor and City Council of the City of Woodbury on February 12, 2020.


