**RESOLUTION OF THE CITY COUNCIL OF THE CITY WOODBURY
AWARDING A CONTRACT TO ARAWAK PAVING CO., INC. FOR THE
FY 2019 LOCAL ROAD PROGRAM**

WHEREAS, the City Clerk and Engineer received bids on January 20, 2020 for the FY 2019

Local Road Program, as set forth below:

WHEREAS, the City Engineer has reviewed the bids received and by correspondence dated January 20, 2020, has recommended award of the Contract to Arawak Paving Co., Inc. for the base bid amount of \$175,900.00 with Alternate 1 of \$44,900.00 for a total bid amount of \$220,880.00; and

WHEREAS, the low bid is compliant in all material non-waivable respects and the amount is consistent with the Engineer's Estimate; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Woodbury that:

1. The contract is hereby awarded to Arawak Paving Co., Inc. for FY2019 Local Road Program in the base bid amount of \$175,900.00 with Alternate 1 of \$44,900.00 for a total bid amount of \$220,800.00.
2. That the Mayor and/or Administrator is hereby authorized to execute a contract in accordance with the project specifications, the afore-described quote, and the within Resolution.


