**WHEREAS**, the City Clerk and Engineer received bids on January 30, 2020 for the FY 2019 NJDOT Railroad Avenue Resurfacing and Improvements Project, as set forth below:

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Woodbury that:



2. That the Mayor and/or Administrator is hereby authorized to execute a contract in accordance with the project specifications, the afore-described quote, and the within Resolution.


