THRESHOLD PURSUANT TO N.J.S.A. 40A:11-3a AND 18A:18A-3(a) et seq.**

WHEREAS, the recent changes to the Local Public Contracts Law gave local contracting units the ability to increase their bid threshold up to \$44,000.00; and

WHEREAS, N.J.S.A. 40A:11-3a, permits an increase in the bid threshold if a Qualified Purchasing Agent is appointed as well as granted the authorization to negotiate and award such contract below the bid threshold; and

WHEREAS, N.J.A.C. 5:34-5 et seq. establishes the criteria for qualifying as a Qualified Purchasing Agent; and

WHEREAS, Robert Law possesses the designation of Qualified Purchasing Agent as issued by the Director of the Division of Local Government Services in accordance with N.J.A.C. 5:34-5 et seq.; and

WHEREAS, the City of Woodbury desires to take advantage of the increased bid threshold;

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Woodbury, in the County of Gloucester, State of New Jersey hereby increases its bid threshold to \$44,000.00 pursuant to N.J.S.A.40A:11-3(a) and 18A:18A-3(a).
