MEETING OF THE MAYOR AND CITY COUNCIL FOR THE YEAR 2021**

WHEREAS, the time for the annual meeting of the City Council of the City of Woodbury has been heretofore fixed and established by a motion of City Council fixing the hour and date for the annual meeting of the City of Woodbury for the year 2021, as January 6, 2021, same being passed at a regular meeting of said City Council; and

WHEREAS, it is the desire of the new City Council to ratify and confirm the acts of the old City Council insofar as they concern such annual meetings;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Woodbury as follows:

1. BE IT RESOLVED by the City Council of the City of Woodbury, the Mayor concurring, as follows:

1. That until further order by the City Council within the provisions of its own by-laws, the business of the Council will be conducted under Robert's Rule of Order.
2. That the standing committees of the City Council shall be four in number and are hereby established as follows:

Finance & Public Safety

- Public Safety (Police, Fire and Emergency Management)
- Budget

City Improvement & Rehabilitation

- Economic Development
- Property Maintenance
- Neighborhood Preservation

Green Team & Beautification

- Recycling
- Environmental
- City Beautification

Community Development

- Community Enrichment
- Special Events
- Parks & Recreation
- Seniors

3. No by-laws, rules of order of Council shall be suspended, altered or amended unless such suspensions, alterations or amendments shall have been presented at a regular or special meeting and adopted at the next meeting by a majority of Council provided, however, that any rule of order of Council may be suspended whenever two-thirds of the members consent thereto, provided further that by unanimous consent of the City Council, any rule may be suspended temporarily at any time except matters controlled by statute.

COUNCIL PRESEDENT’S PERIODS OF ABSENCE**

WHEREAS, on occasions during the legislative year of 2021 because of the pressure of business or personal reasons, it is necessary that the President of City Council of the City of Woodbury, be absent from the City, therefore unable to attend a regular Council meeting during this period of absence; together with the duties and responsibilities granted by the City Charter and City Code; and

WHEREAS, it is the desire of the City Council of the City of Woodbury to provide for the orderly process of business that a President “pro tempore” be appointed with full authority to act in all matters as President of said City Council and as otherwise afforded by the City Charter and City Code; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodbury, the Mayor concurring, as follows:

1. That **COUNCILWOMAN TRACEY PARKER** be and is hereby designated as President “Pro Tempore” of the City Council of the City of Woodbury with all the authority, privileges and powers accorded by law to the President of Council during periods of absence, voluntary disqualifications or the temporary inability of the President of Council to be present at a Council meeting and in addition, together with all rights and responsibilities afforded the position pursuant to the City Charter and City Code.

2. This Resolution shall take effect immediately.

RESOLUTION TO ADOPT A TEMPORARY BUDGET FOR THE YEAR 2021

WHEREAS, it is necessary for the governing body of the City of Woodbury, in order to properly conduct the affairs of the City from the present time until the final adoption of the 2021 budget, to make certain contracts and commitments and to authorize the payment of certain obligations and expenditures; and

WHEREAS, the provisions of Section 40A:4-19 of the Revised Statutes provide for temporary appropriations not in excess of 26.25% of the total appropriations made for all purposes in the budget for the preceding fiscal year excluding, in both instances, appropriations made for interest and debt redemption charges, capital improvement fund and public assistance.

WHEREAS, the temporary appropriations hereinafter made and established are entirely within all limitations imposed by law.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury as follows:

1. That the sum of **Three Million Seven Hundred Seventy Thousand Six Hundred Fifty-Seven and 33/100 Dollars (\$3,770,657.33)** is hereby appropriated to meet and pay the contracts, obligations, commitments and operating expenditures for the Current Fund hereinafter enumerated.

2. The appropriations made hereunder shall be allotted for the following governmental operations in the following sums:

(5) After acknowledgment from the Council President, each person to address the Council must state his or her name and residence or business address.

(6) Members of the public are limited to a five-minute time limit to address the Council during a Public Portion. The time limit may be extended at the discretion of the President of Council with the concurrence of the City Solicitor.

(7) All questions, comments and dialog must be directed to the Council. The council President or his/her designee will either respond or select another member of

council or professional to do so. No intra-audience dialog is permitted during the open session of any meeting.

(8) Speakers may speak only once during a public portion.

(9) Speakers on both sides of the dais shall treat each other with courtesy and respect. Individuals should refrain from using foul language.

(10) At meetings with unusually large attendance, the Council President may impose such additional rules or time limitations as are deemed appropriate from time to time based on business before the Council and the number of persons wishing to speak.

(11) The Council President or City Solicitor will give one warning of improper behavior. On the next offense, the speaker will be asked to relinquish the floor.

7. Where possible pursue grants to offset the costs of providing these programs to our residents, and

WHEREAS, the governing body of the City of Woodbury seeks to undertake a redevelopment effort within the City; and

WHEREAS, N.J.S.A. 40A:12A-6 authorizes the governing body of any municipality, by Resolution, to have its Planning Board conduct a preliminary investigation to determine whether any area of the municipality is a redevelopment area pursuant to the criteria contained in N.J.S.A. 40A:12A-5; and

WHEREAS, the City Council of the City of Woodbury considers it to be in the best interest of the City to have the City’s Planning Board conduct such an investigation regarding **BLOCK 84, LOTS 1, 2, 4, 4.01 AND 6 BLOCK 85, LOTS 1, 2, 3, 4, 5, 24, 24.01, 24.02 AND 24.03, AND BLOCK 86, LOTS 1, 1.01, 2, 3.01, 7, 13, 14 AND 16** which parcels are currently in private ownership, as described and delineated on the official Tax Map of the City of Woodbury; and

WHEREAS, such preliminary investigation will be designed to evaluate such area to determine whether designation of these properties as an “area in need of redevelopment” is in conformance with statutory criteria and the City’s efforts toward redevelopment, pursuant to the Master Plan.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodbury, County of Gloucester, that:

1. The Combined Planning and Zoning Board of the City of Woodbury is hereby directed to conduct a preliminary investigation to determine whether the aforementioned parcels are an area in need of redevelopment according to the criterion set forth in N.J.S.A. 40A:12A-5;

Pursuant to N.J.S.A. 40A:12A-6 the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area including the power of eminent domain (“Condemnation Redevelopment Area”) as to all property within the redevelopment area;

4. The results of such preliminary investigation shall be submitted to the City Council for review and approval in accordance with the provisions of the New Jersey Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq.
