**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY  
AUTHORIZING EXECUTION OF A SHARED SERVICE AGREEMENT BY AND  
BETWEEN THE CITY OF WOODBURY AND THE BOROUGH OF WOODBURY  
HEIGHTS REGARDING POLICE DEPARTMENT SERVICES**

**WHEREAS**, the City of Woodbury and the Borough of Woodbury Heights desire to enter into a Shared Services Agreement regarding Police Department services; and

**WHEREAS**, N.J.S.A. 40a:65-1 et seq. (“Shared Services Law”) specifically authorizes local government units, including counties and municipalities, to enter into Shared Services Agreements.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Woodbury, County of Gloucester, and State of New Jersey as follows:

1. That the City Council does hereby approve and authorize the execution of a Shared Service Agreement between the City of Woodbury and the Borough of Woodbury Heights regarding Police Department services.
2. That the Mayor, Council President and/or Interim City Administrator be and is hereby authorized to execute the Shared Service Agreement on behalf of the City of Woodbury.
3. That the Shared Services Agreement be and is hereby subject to final review and approval by the City Solicitor.
