**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODBURY
APPOINTING A WOODBURY CITY MUNICIPAL CLERK**

WHEREAS, as of August 1, 2020, a vacancy existed for the position of the City of Woodbury Municipal Clerk due to the non-reappointment of the prior City of Woodbury Municipal Clerk as of July 31, 2020; and

WHEREAS, via Resolution 20-121 the Mayor and Council appointed Cassidy Swanson as the Acting Woodbury City Municipal Clerk for a period of one (1) year from August 12, 2020 to August 12, 2021 pursuant to N.J.S.A. 40A:9-133(c); and

WHEREAS, via Resolution 21-120 the Mayor and Council re-appointed Cassidy Swanson as the Acting Woodbury City Municipal Clerk for a period of one (1) year from August 12, 2021 to August 12, 2022 pursuant to N.J.S.A. 40A:9-133(c); and

WHEREAS, Cassidy Swanson has now obtained a Certificate as a Registered Municipal Clerk pursuant to N.J.S.A. 40A:9-133.3; and

WHEREAS, the Mayor and Council of the City of Woodbury wish to appoint Cassidy Swanson as the Woodbury City Municipal Clerk for a three (3) year term pursuant to N.J.S.A. 40A:9-133, et seq.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Woodbury, that Cassidy Swanson is hereby appointed as the full-time Woodbury City Municipal Clerk effective June 22, 2022 for a three (3) year term pursuant to N.J.S.A. 40A:9-133 et seq.


