Then continue to complete each of the fields in order to populate throughout the workbook. If a utility(s) exist, enter the type of utility into the fields listed.
- g) In all applicable signature lines insert appropriate officials email address.
- h) The completed AFS must be submitted to the Division, via the FAST portal and it must be precisely named as: xxx\_xxx\_20YY.xls (all 4 digits must be included).
- i) Only the Chief Financial Officer has access to the submit for review tab within the FAST portal.
