### NARRATIVE

#### Speeding Complaint – Fourth Street & Central Ave

#### *Resident Complaints*

A resident reported vehicles speeding on Fourth Street and Central Avenue. The complainant requested a speed study be conducted in the area and also requested a four-way stop at the intersection. Currently, the intersection is controlled by stop signs on Central Avenue, and Fourth Street has the right of way. I conducted a crash analysis which showed there has been one (1) motor vehicle crash in the past ten (10) years. This crash was not within the intersection and the cause was not due to a motorist failing to stop at the stop sign.

On Thursday, April 10, 2025, I deployed the covert Jamar Radar Recorder in the area of Fourth Street by Central Ave. The Jamar Radar Recorder was affixed to a nearby telephone pole and recorded both Northbound and Southbound traffic on Fourth Street. The Radar Recorder was deployed for a period of eight (8) days and recorded 2,179 vehicles.

I then downloaded the data from the recorder and produced a Speed Enforcement Evaluator Sheet, along with a Data Summary. The Speed Enforcement Evaluator was calibrated for an Enforcement Tolerance of 6 MPH, or a vehicle speed of 32 MPH and above. I also produced a Speed Enforcement Evaluator with an Enforcement Tolerance set at 10 MPH or a vehicle speed of 36 MPH and above. The following are the results of the data:

### **Speed Enforcement Evaluator (32 MPH and above):**

The total percentage of Enforceable Violations (Vehicles traveling over 32 MPH) was found to be LOW with 1.4% of vehicles above the limit (32MPH).

### **Speed Enforcement Evaluator (36 MPH and above):**

The total percentage of Enforceable Violations (Vehicles traveling over 36 MPH) was found to be LOW with 0.2% of vehicles above the limit (36MPH).

I then produced the Data Summary for the Traffic Study. The combined speed statistics (for Northbound and Southbound traffic) revealed that the Average Mean Speed of vehicles was 23MPH. It was found that no vehicles were traveling over 40 MPH.

On Friday, April 18, 2024, I deployed the covert Jamar Radar Recorder on Central Ave, approximately halfway between Fourth Street and Third Street. The radar recorder was deployed for seven (7) days but only recorded data for five (5) days before the batteries depleted. 1,684 vehicles were recorded.

I then downloaded the data from the recorder and produced a Speed Enforcement Evaluator Sheet, along with a Data Summary. The following are the results of the data:

The total percentage of Enforceable Violations (Vehicles traveling over 32 MPH) was found to be LOW with 3.3% of vehicles above the limit (32MPH).

## Speed Enforcement Evaluator (36 MPH and above):

The total percentage of Enforceable Violations (Vehicles traveling over 36 MPH) was found to be LOW with 1.5% of vehicles above the limit (36MPH).

I then produced the Data Summary for the Traffic Study. The combined speed statistics (for Eastbound and Westbound traffic) revealed that the Average Mean Speed of vehicles was 22MPH. It was found that 9 vehicles were traveling over 40 MPH, out of 1,684. This accounts for 0.53% of traffic.

It was found that there is not a speeding issue at the target locations. The results reveal that the complaining resident might be observing a volume issue for the size of the residential street. The perception of vehicle speed can also be inflated to a pedestrian or observer who is not moving.


It should be noted that the Stop Lines and crosswalks at the intersection of Fourth Street and Central Ave are washed away to the point that they are almost entirely unnoticeable. **It is recommended that minimally the stop lines on Central Ave be repainted to the MUTCD (Manual on Uniform Traffic Control Devices) standards**, which may increase visibility of the traffic control devices for motorists approaching the intersection.
