NARRATIVE

Speeding Complaint - Glenwood Ave
Resident Complaints

A resident reported vehicles speeding on Glenwood Avenue. The complainant requested a speed study be conducted in the area.

On Friday, August 22, 2025, I deployed the covert Jamar Radar Recorder in the area of Glenwood Ave between Walnut Ave and Glenwood Ct. The Jamar Radar Recorder was affixed to a nearby telephone pole and recorded both eastbound and westbound traffic on Glenwood Ave. In the documents, Lane 1 is the eastbound direction and lane 2 is the westbound direction. The Radar Recorder was deployed for a period of eight (8) days and recorded 1,226 vehicles.

I downloaded the data from the recorder and produced a Speed Enforcement Evaluator Sheet, along with a Data Summary. The Speed Enforcement Evaluator was calibrated for an Enforcement Tolerance of 6 MPH, or a vehicle speed of 32 MPH and above. I also produced a Speed Enforcement Evaluator with an Enforcement Tolerance set at 10 MPH, or a vehicle speed of 36 MPH and above. The following are the results of the data:

Speed Enforcement Evaluator (32 MPH and above) :

The total percentage of Enforceable Violations (Vehicles traveling over 32 MPH) was found to be **LOW** with 9.6% of vehicles above the limit (32MPH).

<p>The total percentage of Enforceable Violations (Vehicles traveling over 36 MPH) was found to be LOW with 2% of vehicles above the limit (36MPH).</p> <p>I have attached both Speed Enforcement Evaluator Sheets to this report for reference.</p> <p>I then produced the Data Summary for the Traffic Study. The combined speed statistics (for eastbound and westbound traffic) revealed that the Average Mean Speed of vehicles was 25 MPH. Of the 1,226 vehicles, 3 were traveling in excess of 40 MPH, which equates to 0.24% of traffic. The 85th percentile speed is 30 MPH, meaning that 85% of traffic is traveling at or below 30 MPH.</p> <p>It was found that there is not a speeding issue at the above location. The results revealed 85% of traffic traveling below 30 MPH with only 3 vehicles in one week above 40 MPH. The perception of vehicle speed can sometimes be inflated to a pedestrian or observer who is not moving and who is not trained in calculating vehicle speeds.</p> <p>Detective J.
