## **Important Election Information**

May 25, 2022

Dear Woodbury Resident(s) and Registered Voter(s),

During the week of May 2, you should have received a post card in the mail, sample shown below, from the Gloucester County Board of Elections;

Dear Voter(s)

Pursuant to NJSA 19:4, the Gloucester County Board of Election Commissioners have approved and authorized the creation, consolidation, re-alignment, or polling location changes, of voting districts/wards in your municipality.

Your Municipality, Ward, District, and Congressional District Are:

Municipality = **Woodbury City**

Ward = **02**

District = *either 01, 02, or 03*

Congressional District = **01**

Your Polling Location is:

**BETHEL AME CHURCH**

**32 COURTLAND ST WOODBURY, NJ 08096**

Your new polling place location, district, and/or ward will be printed on all future sample ballots you receive prior to each election. If you have any questions, please call the Office of Elections at 856-384-4501. Thank you for your time and attention to this matter.

The 2020 U.S. Census Data showed a population disparity in the City's First Ward and Second Ward. As a result, the Gloucester County Board of Election Commissioners authorized the boundary change of the Second Ward, in which the Second Ward cedes population to the First Ward, to re-balance population representation. The population from the Second Ward that got redistricted into the First Ward is now a part of Ward 1, District 1.

Additionally, the Gloucester County Board of Election Commissioners authorized the consolidation from four districts to three in the Second Ward, and the consolidation from two polling locations to one in the Second Ward. The Polling Location for Second Ward is Bethel AME Church located at 32 Courtland Street. There are no boundary, district, or polling location changes to the City's Third Ward.

The enclosed Ward and District Map shows the new changes stated above. Please reference the Map or the card the Gloucester County Board of Elections mailed out for any Ward, District or Polling Location changes.

Early In Person Voting for the Primary Election on will be taking place Friday, June 3<sup>rd</sup> and Saturday, June 4<sup>th</sup> from 10 am to 8 pm and Sunday, June 5<sup>th</sup> from 10 am – 6 pm. Gloucester County Voters may go to any of the 5 designated early voter centers. The 2 closest to Woodbury

are Riverwinds Community Center, located at 1000 Riverwinds Dr., Thorofare, NJ, 08086, and RCSJ Business and Corporate Center, located at 1400 Tanyard Rd., Sewell, NJ, 08080.

If you requested and received a Vote-By-Mail ballot, there are 12 Secure Vote-By-Mail Ballot Drop Boxes located throughout Gloucester County. The 2 closest to Woodbury are located outside of the Gloucester County Administrative Building, located at 2 S. Broad Street, Woodbury, NJ, 08096, and outside of the Gloucester County Office of Elections, located at 550 Grove Rd., Paulsboro, NJ, 08066 (GPS Address). You can deliver your Vote-By-Mail Ballot in person to the Gloucester County Office of Elections until 8 pm on Tuesday, June 7.

All Polling Locations will be open from 6 am to 8 pm on Tuesday, June 7. You cannot return your Vote-By-Mail ballot at a polling location.
